




Not All Disabilities are Visible

20% of adults suffer from a mental illness

10.8% suffer from intellectual disability

24% of US population has some sort of disabilities and this number is rising.



Each day, 10,000 baby boomers retire and begin receiving Medicare and Social Security benefits.



Affordable, accessible, and well-located housing is central to quality of life for people of all ages - Harvard Joint Center for Housing Studies and the AARP Foundation

Americans with Disabilities Act

Prohibits discrimination on the basis of disability in employment, State and local government, public accommodations, commercial facilities, transportation, and telecommunications.

The ADA does not specifically name all of the impairments that are covered.

Americans with Disabilities Amendment Act

Passed in 2009

Gave formal definitions of a disability and reasonable accommodation

Changes the way some terms are used under ADA Law

Gives the courts strong terms to support individuals with disabilities

What is a Disability?

A person with a disability as a person who has a physical or mental impairment that substantially limits one or more major life activity. This includes people who have a record of such an impairment, even if they do not currently have a disability. It also includes individuals who do not have a disability but are regarded as having a disability. The ADA also makes it unlawful to discriminate against a person based on that person's association with a person with a disability.

Major life activities include a wide variety of daily activities,

such as the following: caring for oneself, performing

manual tasks, walking, seeing, hearing, speaking,

breathing, learning, and working.

What is a Reasonable Accommodation?

A reasonable accommodation is an adjustment made

in a system to accommodate or make fair the same

system for an individual based on a proven need.

Needs can vary.

Major Bodily Function

Major life activities also include the operation of

major bodily functions such as **brain**, **immune**

system, respiratory, neurological, digestive, and

circulatory functions.

Universal Design

"Only 1% of the American home supply meets at least 5 of the seven principles of Universal Design."

7 Universal Design Principles

- 1. Equitable Use
- 2. Flexible Use
- 3. Simple and Intuitive
- 4. Perceptible Information
- 5. Tolerance for error
- 6. Low Physical effort

7. Size and space for approach and use regardless of body size, posture, or mobility


Areas Brokers Should Be Knowledgeable

- Parking
- Ramps
- Meeting Areas
- Doors
- Bathrooms

Parking Requirements

Signage: international symbol of accessibility placed in front of the parking space mounted at least five feet above the ground, measured to the bottom of the sign. Van accessible spaces include the designation "van accessible".

Van Accessible Spaces: 2010 Standards—one for every six accessible spaces (1991 Standards record one for every eight)




Space width for van: 11 feet (although it may be eight feet wide if its access aisle is eight feet wide)

Access aisle:

Width: five feet (if aisle serves car and van spaces) Length: full length of parking space








Reinforced Walls For Grab Bars



Bathroom Safet & Function

- → Curbless roll-in shower
- → Support bars & handrails
- → Adjustable height showerhead
- → Shower seating
- → Lever handle faucet
- → Non-slip tile
- → Additional lighting



Bathroom Safety & Function

→ Accessible lavatory
→ Tilt mirror
→ Lever faucet

Visitability: Everyone benefits 3 basic requirements:

- → A zero-step entrance
- → Doors with 36 inches of clear passage space
- → One bathroom on the main floor where you can get into in a wheelchair




Only 1% of housing units in the country have basic accessibility features (2011 American Housing Survey)

→ Wide Doorways (32" width)



Spacious Layout

→ hallways and doorways free from clutter and at least 48" wide

- Difference between Service Animals & Emotional Support Animals
- ESA allowed in "No Animals" complexes and rentals
- Allowed to ask for letter from Mental Health Professional
- Check website to see if the MHP is on the con-website
- Service Animals "what services do they provide?"
- > 2nd Degree Misdemeanor \$500 fine and/or 60 days in jail
